Mr. Engel noted that the Village is in the process of increasing the reserves by \$250k and that income was up by approximately 48% for January.

- Ordinance 23.10 Amending Procedures for Termination of Employees
 - When question, Mr. Miller acknowledged that this ordinance was requested by Mr. Baldridge and Mr. Perdue. He also acknowledged that Chairman Holcomb, Mr. Engel, and Mr. Weiss were not part of the request or drafting of this document.
 - Mr. Perdue stated that there were no preliminary drafts and that this final draft was the only document submitted.
 - Chairman Holcomb protested the bold and capitalized portion of the ordinance requiring him to sign upon passage as this has never been done historically.

- o Mr. Engel motioned for tabling the ordinance as it was just presented 2 days prior and needs discussion and clarification of legality. Historically 4/5ths vote has been required and he considers the 3/5ths amendment railroaded to fit Mr. Baldridge's and Mr. Perdue's needs and not in the best interests of the Village. No second motion received. Motion failed.
- Mr. Engel inquired how long has this ordinance been in process and Mr. Miller declined to answer.
- o Mr. Baldridge pressed to move forward with the reading of the ordinance.
- Chairman Holcomb stated that the ordinance could not be read twice by title only as it wasn't posted. Mr. Miller disagreed and stated a copy was on put a chair at the door just prior to the meeting. Chairman Holcomb said that did not meet posting requirements.
- o Mr. Baldridge again stated let just read the ordinance.
- Chairman Holcomb stated the clerk must attest for ordinance to be in effect. Mr. Miller disagreed. Chairman Holcomb read the state statutes requiring the clerk attest. Clerk was not present due to COVID.
- o Mr. Baldridge again pressed to read the ordinance.
- o Mr. Perdue read the ordinance once in full.
